# About the Role

Humanity in Action is seeking a part-time Communications & Administrative Intern to support our Senior Fellow (alumni) engagement initiatives. This remote role is ideal for someone who is highly organized, has a strong eye for detail, and is passionate about using communications and operational tools to build community and advance human rights.

The intern will report to the International Operations Director and work closely with the Community Engagement Manager and contribute to both backend administrative workflows and outward-facing communications projects. The role is fully remote, with working hours ideally compatible with Europe or the East Coast US.

- Draft, edit, and refine content such as social media posts, event recaps, and news updates aligned with Humanity in Action's voice and style.
