# CLIMATE CHANGE, HUMAN RIGHTS & DEMOCRACY

---

## Rights of Future Generations

As we witness temperature peaks, sea level rise, flooding, drought and wildfires, the consequences of Climate Change are no longer a faraway future but present in the everyday life of many people around the planet.

Climate Change is affecting all of us; with its myriad of impacts and rarely in uniform ways. Vulnerable and marginalized peoples are often hit disproportionately harder. With little or no resources to adapt, this further exacerbates the adverse effects.

Environmental degradation does not exist in a vacuum but is entangled in existing systems of inequality and oppression. The people who have contributed the least to Climate Change often suffer the most from its consequences. Therefore it is crucial to work towards climate justice, and implement right-based approaches.

The 2025 Copenhagen Fellowship will explore the complex relationships between Climate Change, Human Rights and Democracy by asking:



**Is Climate Change threatening the effective enjoyment of Human Rights? How can we counter its disproportionate effects? And how can we use Democracy and Human Rights effectively to build a just future for all?**

The impacts of Climate Change will continue to increase if drastic cuts in emissions are not implemented immediately, threatening younger generations, children and yet unborn. Yet, they have little to no voice in the decisions made today. All generations - past, present and future - hold the Earth in common. The Copenhagen Fellowship will explore how to meet the needs of present generations without compromising the needs and **Rights of Future Generations.**

We believe YOUR voice matters. Hence, we are collaborating with *Talerskolen RØST* (the Speech School VOICE) to strengthen YOUR voice, your courage to speak up, and your ability to make people listen.

Most importantly, this Fellowship is about connections. We hope you are ready to show up, take your seat at the table, speak up, reflect and deeply listen to each other to build community and create change!

Addressing incidents of misconduct is essential in upholding our values and maintaining a safe and respectful environment for all participants. By following this protocol, Fellows and staff (Network Members) contribute to fostering a culture of accountability and mutual respect within the HIA community.

The Code of Conduct describes Humanity in Action's expectations for the behavior of its Network Members throughout their participation in the Fellowship programs and all other network activities. The envisioned purpose of this Code of Conduct is to promote a constructive learning environment for all Network Members, particularly our Fellows. Guest speakers, volunteers, freelancers, and trainers will also be informed about our network's Code of Conduct.

The Code of Conduct is not intended to be comprehensive or to address all possible applications of, or exceptions to, Humanity in Action's expectations. Nor is it intended to, in any way, limit a Network Member's rights to communicate with a government agency, as provided for, protected under, or warranted by applicable law. In addition, we understand that different terms mean different things in different contexts, languages, and countries. If you have any questions, please ask for clarification.

**Anne Katrine Ebbesen is our Ombudsperson**, our designated point of contact to serve members of the Humanity in Action network, including the Fellows of this program.

**The objective of the ombudsperson** is to ensure a safe and respectful environment within the Humanity in Action community by providing clear procedures for addressing situations that are not in line with the organization's Code of Conduct (see previous page).

**The ombudsperson's role** is to (1) serve as a designated point of contact for members experiencing or witnessing misconduct. (2) Provide an open, respectful, and safe environment for all affected individuals who reach out, and provide them with confidential advice and support. (3) Manage the subsequent actions, consequences, and interventions stemming from each report. Every report is taken seriously, and the Ombudsperson assumes responsibility

for the necessary actions and interventions. However, not every report will automatically lead to an intervention; decisions are made considering the duty of care of the organizers and the well-being of the reporting or affected individual, with a focus on de-escalation.

*When interacting with the Ombudsperson, you have the autonomy to choose:*

- How and when you make your report (e.g., during the Fellowship or afterwards).
- How much detail you provide about your experience.

The Ombudsperson is not a counselor or psychotherapist. If Fellows or team members need psychosocial assistance or support, they will be directed to relevant counseling centers and resources.

# CREATING CONSTRUCTIVE DIALOGUE

---

## Through common values

### GOOD AND CONSTRUCTIVE DIALOGUE

We communicate with each other all the time, therefore, how we communicate is central to the way we interact as human beings and how we function as a group. Together we will work to create the best possible foundation for good and constructive dialogue and communication - when we agree and when we disagree.



**A good, open, and respectful dialogue is crucial for change and, therefore, crucial for Humanity in Action. Throughout the Fellowship we will work together to achieve good and constructive dialogues.**

But what determines a "good" dialogue or a "good" conversation? A good dialogue and a good conversation can have many forms and may be interpreted in many different ways.

Humanity in Action emphasizes an open and inclusive dialogue as an important value for "good" communication.

But what does it mean to you? In collaboration, you will define what good communication means to you and the 2025 Fellowship cohort, and you will create a foundation of common group values together.

### WHAT ARE VALUES – TO YOU?

Values can be said to be culturally determined perceptions of what is valuable and desirable, and what is not.

Every human being lives their life based on their values which have often been determined in an early stage of life. Our day-to-day actions are influenced by our values, often without conscious awareness. These implicit values are shown through our interactions with others.

Values are more often than not implied and not necessarily mentioned explicitly. Without explicit verbalisation, values are expressed through our communication and attitudes toward other people.

This can be expressed in the way we begin and end a conversation, how we listen, how we respond, if we are attentive towards others, and finally, what words we choose when we speak with each other.

We are curious to learn what values **you** would like during the Fellowship in order to create open and constructive communication.

Throughout the Fellowship, we will explore which values are especially important to you and how you would like them to be expressed in the way we communicate with each other.

# PRACTICAL INFORMATION



# LOGISTICS

---

Lunch will be provided on all program days, and will be sensitive to individual dietary restrictions. When at Globalhagen, our main venue, lunch will be served warm and **organic**. When we are on tour, lunch will be take-away items, such as sandwiches.

You are responsible for your own breakfast and dinner. As well as all meals on days without a structured program. Some host families/accommodations may provide breakfast and some dinners.



The Copenhagen Fellowship will take place in several different locations in Copenhagen. It is your responsibility to check which location we will be at each day of the Fellowship. The location will appear in the day-to-day program.

**Important!** Fellows and staff must respect the spaces that we have been invited into.

We expect you will keep them in good shape and order, tidy up after yourselves, and be mindful of other activities that might take place in these locations while we are there.

Fellows from abroad will be equipped with a travel card for public transportation. This will **not** cover all transportation during the Fellowship, only to/from your accommodation and fellowship venue. Should you have any issues with getting to the locations, you may always contact the staff.



Fellows from abroad are offered to stay with a host family, hostel or dorm depending on availability and possibilities. This may vary from year to year. Fellows are asked to be sensitive to their hosts' expectations, show openness to get to know the host and their families, as well as take part in the daily routines of the host and assigned chores.

**People outside the Fellowship are not allowed to stay overnight in any Humanity in Action-sponsored accommodation without pre-approval from Staff, and where applicable, hosts.**

# PROGRAM COMPONENTS

---

Every year our program consists of a number of fixed components. Read about them below, and other important elements of the program you can expect to meet:

## CHECK-IN & CHECK-OUT

These are important components of our everyday schedule. They will usually take around 15 minutes and are meant as spaces of transition where we prepare ourselves to either begin or end the day together.

They might sometimes include energizers, teambuilding, reflections or meditations. You are welcome to suggest how to start and end the day in a meaningful way.

***We expect you to be on time and ready every morning for our check-in.***

## LECTURES

Every day we will have lectures focusing on different aspects of our theme. Some will be more workshop oriented, others will be discussion oriented, but many will also be classical lectures. We have asked all speakers to leave plenty of room for questions and engaging in dialogue with you.

## ACTION PROJECT WORKSHOPS

We have a number of workshops throughout the program where you can work on your Action Project and to inspire you to go from *passion* to *action*.

## FELLOW SESSIONS & FOLLOW-UPS

The **Follow-Ups** are meant as 20-30 minutes after a lecture, or a series of lectures, where you reflect in groups, in pairs or by yourself on the lecture/s you've just had: What are your main take-aways, what especially resonated with you - or not! - what would you like to know more about, how can you use this information you just received etc.

The **Fellow Sessions** are designed to provide you with a space for you to discuss a topic, initiate a workshop or a creative spaces you feel is missing from the program. Or simply just share something you are passionate about with your peers!

***We invite you to take turns in leading the Fellow Sessions, by yourself or in groups.***

## EXCURSIONS

We have a number of excursions and site visits during the program to get you out of the classroom and into the field - literally!



## GROUP VALUES

We are in this space together, we are learning together and discussing with one another - sometimes emotional topics close to our hearts.

We will begin this Fellowship by exploring our values and identifying and operationalizing common values.

How do we each show up to make a compassionate space for learning. How do we practice democracy and make space for different opinions. What does respect and open-mindedness mean to you? And what kind of behaviour supports active listening?



## BREATHING SPACES

During lunch breaks, we will be providing a **Breathing Space**.

In a world of immense suffering, it is easy to get overwhelmed and locked in states of apathy or anxiety. Meditation can help us sit with recognise what goes on in body and mind, and make space for it to move.

You will learn how to sit with discomfort and hold yourself and others with compassion - supporting not only your wellbeing but also your capacity to take pro-social actions.



## SPEAKER PRESENTATIONS

We would like each of you to introduce a speaker before their lecture/workshop. Sign up for a speaker to present at the beginning of the program.

## OPEN EVENTS

During the program some of our events are open to the public. These events are designed to engage the wider public in our conversations.

August 18 Clement Kjersgaard will be speaking about ***The World in Crises - Where Are We Heading?*** August 26 we will screen the award-winning Bosnian film "***Quo Vadis, Aida***" about the genocide in Srebrenica in 1995 with a subsequent talk, and on August 27 you will be giving a speech about **Defending Tomorrow!**

Feel free to invite your friends, families, host family and others who might be interested!

## GOODBYE DINNER

August 28 is our last day together. We will mark the end of our time together in Copenhagen with a dinner and a party at our main venue, Globalhagen House.

Our food will be prepared by **Send Flere Krydderier** (*Send More Spices*), an eatery with a social agenda and dishes from all over the world, located in the heart of Nørrebro.

We encourage you to make this day special and thus invite you to join in the planning of the dinner and party.

# VENUES

---

## OUR MAIN VENUE: GLOBALHAGEN HOUSE

We will spend most of our program days at **Globalhagen House**. This is a dynamic hub for NGOs, humanitarian initiatives, political parties and businesses looking to collaborate and create change. Their mission originates from Mellempfolkeligt Samvirke (ActionAid Denmark), a Danish NGO fighting for human rights and poverty alleviation in more than 45 countries. The profit from Globalhagen House goes towards creating a more just and sustainable world. So we're not just guests at Globalhagen, we are an active part of an important cause!



*Globalhagen House* is located in the district of **Nørrebro** in Copenhagen. Nørrebro is known for its multiculturalism, vibrant nightlife, and diverse food scene. It's a popular area for young people, with a mix of trendy and traditional shops, bars, and restaurants, as well as historical landmarks like Assistens Cemetery. On **August 20** we will take you on a city walk through the neighbourhood to explore its hidden gems and history of activism and migration.



## YOUTH ISLAND

August 15-16, we will go to The Youth Island. It is an old sea fortress from 1894. In 2015 it was bought by A.P. Møller and the Nordea Foundation and given as a gift to the youth. It aims to strengthen young people in their journey to become active, committed, and curious citizens.

We will spend the night there. **Remember to bring your swimming suit, if you want to swim** (All meals, towels, and linen will be provided, but anything else you will need to bring from home as there are no shops).

***It's not permitted to bring alcohol to the island.***

## THE YOUTH DEMOCRACY HOUSE

August 21 we're in **Ungdommens Demokratihus** (Youth Democracy House). It is a communal space for young people, and it is placed in Copenhagen's Meat Packing District, which is particularly busy at night!

## UN CITY, ARC & COPENHILL

On August 14 we will first visit UN-City Copenhagen for a talk on **Just Energy Transitions**.



Next, we will go to *Amager Ressource Center* (ARC) for a guided tour on **transforming waste to energy**. On the way there we might stop by the **Opera Park** for lunch. The park is designed with sustainable practices, including rainwater management systems and solar panels.

***Important: It is a requirement that you wear long trousers and practical, closed shoes when you visit ARC. No access to the facility with flip-flops, sandals or high-heeled shoes. Due to the many steps, you must be healthy, walking and mobile to get a tour inside the facility, and you must wear a helmet and safety vest on the tour.***



## CINEMATEKET

For our OPEN EVENT on August 26, we will go to **The Cinematheque**, a film & cultural center dedicated to exploring the art and history of film.

## FARENDLØSE MOSTERI

On August 25 we will go to a regenerative producer community in the countryside. Originally a cider mill, the first apple tree was planted in 1912. Today, the place is not only a mill, but also an active farm home to several small businesses and a school where young people learn how to produce in a regenerative ways that mitigates climate change and supports biodiversity. In the afternoon, Katja will invite you into her home - just a walk from the farm.



## SPEAKER'S CHAIR

August 27 we will take on **Speaker's Chair** in *Fælledparken*. 112 years old, the big granite stone has been home to many speeches, especially workers and unions' May Day speeches calling for their rights. Today, you will step up onto the stone and speak up on the **Rights of Future Generations** asking the current generations to act.

## **The Nexus of Climate Change, Human Rights & Democracy**

Today we will dive into the nexus of Climate Change, Human Rights and Democracy. We will, among others, ask questions like 'What are Human Rights?', 'Is Climate Change threatening the effective enjoyment of them?', 'How can we counter its disproportionate effects?', 'How can we understand the causes and consequences of Climate Change?', and 'How can we effectively respond to them?'



# COMMUNITY HUBS

---

## For Fellows by Fellows

After the Fellowship program, Humanity in Action invites the 2025 Fellows to continue growing as an engaged, international community. Community Hubs are an opportunity to stay connected across cohorts, deepen relationships, and support one another in the post-program phase—including the implementation of Action Projects.



**This initiative builds on the belief that leadership is a continuous, shared process—and that strong communities don't just happen, but are intentionally nurtured.**

### WHAT TO EXPECT

Between September 2025 and March 2026, each cohort (Amsterdam, Berlin, Copenhagen, and Sarajevo) will organize one 90-minute online meeting. These sessions will be designed **by Fellows for Fellows**, offering space to explore themes that feel timely, relevant, or personally meaningful. Each Community Hub meeting should include two key elements:

- 1) Input – such as a short presentation, personal story, or moderated conversation. Speakers are welcome and may come from within the cohort.**
- 2) Exchange – dedicated time for peer-to-peer dialogue, ideally in breakout rooms, to foster reflection, learning, and connection.**

In May 2026, HIA will host a final online gathering for all 2025 Fellows to share learnings, insights, and the outcomes of their Action Projects

### GOALS OF THE COMMUNITY HUBS

- To offer a platform where Fellows can continue practicing their leadership by shaping content, guiding dialogue, and co-creating meaningful experiences.
- To encourage Fellows to define the topics and formats that matter most to them— within the spirit and values of Humanity in Action.
- To sustain community engagement beyond the Fellowship through collective reflection, mutual support, and peer learning.
- To promote cross-cohort exchange and international collaboration. To support public speaking, facilitation, and communication skills in a low-pressure, peer-led environment.

### IMPLEMENTATION & COMMUNICATION

Each cohort will be responsible for organizing their Community Hub meeting—deciding on the theme, speakers, format, and facilitation. This process is intended as a practical exercise in collaborative leadership. Fellows are also expected to take the lead in engaging their peers—using inclusive and clear communication to promote the event, encourage participation, and build a sense of shared ownership. HIA staff will provide guidance and technical support as needed, while trusting Fellows to lead the way.
